Reservation and Payment Process

- **Complete the MESPA NAESP Travel Reservation form.**

A surcharge may be added by the hotel or airline due to current variability in fuel prices; in that event, travel package participants will be invoiced the additional amount.

Requests for payment by credit card will be subject to an additional 3.5% service charge.

Air seats and hotel rooms are limited. Reservations are confirmed by date of deposit.

Flight numbers and times may be subject to slight changes before departure date.

Travel documents arrive two weeks prior to departure.

Air fare subject to increase if payment is not received by the due date.

After final payment, airline restrictions apply and tickets are non-refundable.

Hotel and transportation cancellation restrictions apply after final payment.

Add \$25 for late registration or late final payment.

Travel insurance is available.
